WNEREAS, this Sanggurian is in receipt of a letter dated April 24, 2008 from the Honorable City Mayor Eric C. Codilla requesting the Honorable Members of the 11th Sangguniang Panlungsod for the passage of a resolution demanding the National Food Authority to take implementing measures for the early arrest of the escalating price of rice, before the situation becomes hard to control;
