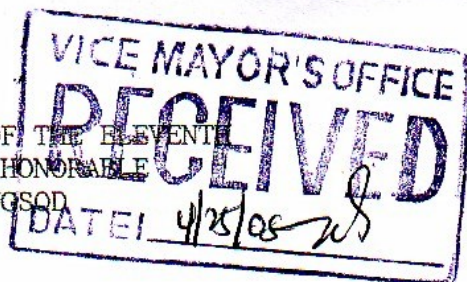

RESOLUTION NO. 2008-078

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO ENTER INTO AND SIGN THE RENEWAL OF THE RICE LOAN MEMORANDUM OF AGREEMENT (MOA) FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC WITH THE NATIONAL FOOD AUTHORITY (NFA).

WHEREAS, this Sanggunian is in receipt of a communication from Ms. Delia S. Borinaga, Executive Assistant III of the City Mayor's Office requesting for a passage of a resolution renewing the Rice Loan Memorandum of Agreement (MOA) and granting authority the Honorable City Mayor Eric C. Codilla to sign the Memorandum of Agreement for and in behalf of the City Government of Ormoc, with the National Food Authority;

WHEREAS, the intent of the said Memorandum of Agreement (MOA) is to allow the Ormoc City Government to purchase rice from the National Food Authority in a credit bases so as to provide basic social services such as relief operations during declared state calamities in the locality and for stockfiling in preparation of eventualities/emergencies that may occur at any given time;

WHEREAS, this august Body finds all the provisions of the Memorandum of Agreement as just and reasonable, hence, the same should be accorded the necessary due course of action;

WHEREFORE, FOREGOING PREMISES CONSIDERED, on motion of City Councilor City Sotero M. Pepito, jointly seconded by City Councilors Jose C. Alfaro, Jr. and Mariano Y. Corro; be it


