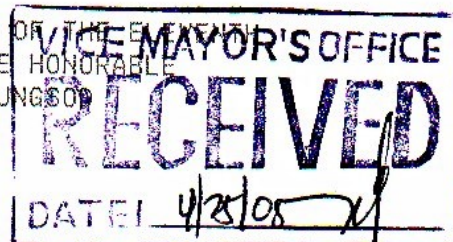

by City Councilor Ruben R. Capahi; be it


RESOLVED, AS IT IS HEREBY RESOLVED, to pass A RESOLUTION TRANSFERRING


