

RESOLUTION NO. 2008-081

A RESOLUTION APPROVING ORDINANCE NO. 2008-001 OF THE
BARANGAY COUNCIL OF BARANGAY COGON, THIS CITY,
ENTITLED: "AN ORDINANCE PROHIBITING THE WASHING OF
CLOTHES, TAKING A BATH AND WASHING ANY KIND OF MOTOR
VEHICLES AT THE ARTESIAN WELL LOCATED IN FRONT OF THE
COGON ELEMENTARY SCHOOL CAMPUS, PROVIDING PENALTIES IN
VIOLATION THEREOF".

WHEREAS, this Sanggunian is in receipt of Barangay Ordinance No. 2008-001 of the Barangay Council of Barangay Cogon, entitled: "AN ORDINANCE PROHIBITING THE WASHING OF CLOTHES, TAKING A BATH AND WASHING ANY KIND OF MOTOR VEHICLES AT THE ARTESIAN WELL LOCATED IN FRONT OF THE COGON ELEMENTARY SCHOOL CAMPUS, PROVIDING PENALTIES IN VIOLATION THEREOF";

WHEREAS, the Sangguniang Panlungsod ng Ormoc, in relation to the aforesaid ordinance at issue (all ordinances of the Sangguniang Barangay in Ormoc City) is, by law, granted the Power to review as to whether said ordinance is consistent with law and city x x x ordinances; (Sec. 57, 1991 LGC)

WHEREAS, it is the observation of this august Body that the said ordinance has conformed to the pertinent provisions of the Local Government Code, hence, reasonable and within the province of the Sangguniang Barangay of Cogon to legislate;

WHEREFORE, foregoing premises considered, on motion of the City Councilor Demosthenes F. Tugonon, Chairman; Committee on Laws and Ordinances, duly seconded by City Councilor Mariano Y. Corro; be it
