RESOLUTION NO. 2008-085

A RESOLUTION APPROVING ORDINANCE NO. 01 SERIES OF 2008 OF THE BARANGAY COUNCIL OF BARANGAY TONGONAN, THIS CITY, ENTITLED: "AN ORDINANCE REQUIRING ENERGY RESOURCE DEVELOPERS (ERD), POWER PRODUCERS, AGENCIES OF THE NATIONAL AND LOCAL GOVERNMENT UNITS, INCLUDING ITS CONTRACTORS TO COMPLY WITH THE PROVISIONS OF ENERGY REGULATIONS NO. 1-94, SECTIONS 6(B) (C) (D) AND BARANGAY TAX ORDINANCE NO. 03-01, SECTIONS 1 AND 2.

WHEREAS, this Sanggunian is in receipt of Barangay Ordinance No. 01 Series of 2008 of the Barangay Council of Barangay Tongonan, entitled: "AN ORDINANCE REQUIRING ENERGY RESOURCE DEVELOPERS (ERD), POWER PRODUCERS, AGENCIES OF THE NATIONAL AND LOCAL GOVERNMENT UNITS, INCLUDING ITS CONTRACTORS TO COMPLY WITH THE PROVISIONS OF ENERGY REGULATIONS NO. 1-94, SECTIONS 6(B) (C) (D) AND BARANGAY TAX ORDINANCE NO. 03-01, SECTIONS 1 AND 2.
