

A RESOLUTION APPROVING BIDS AND AWARDS COMMITTEE (BAC)
RESOLUTION NO. 2008-058, ENTITLED, "A RESOLUTION
RECOMMENDING THE ADDITIONAL PIPE LAYING OF THE
TRANSMISSION AND DISTRIBUTION MAINS OF SUB PROJECT 18 OF THE REHABILITATION/IMPROVEMENT/EXPANSION SIX/ZONE 1 OF THE ORMOC CITY WATERWORKS SYSTEM/PHASE DEVALOPMENT OF WATER SYSTEM AT HERMOSILLA DRIVE, OSMEÑA EXT. AND AGUA DULCE TO BANTIGUE, ORMOC CITY BE UNDERTAKEN THROUGH A NEGOTIATED CONTRACT WITH THE SAME CONTRACTOR, PHILIPPINE RIGID CONSTRUCTION CORPORATION THE AMOUNT OF ONE MILLION SIX HUNDRED THIRTY FOUR IN FIVE THOUSAND EIGHT HUNDRED THIRTY [P1,634,835.44) PESOS ONLY" AND FURTHER AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN THE SAID NEGOTIATED CONTRACT FOR AND IN BEHALF OF THE CITY GOVERNMENT WITH THE PHILIPPINE RIGID CONSTRUCTION CORPORATION.

WHEREAS, the Eleventh Sangguniang Panlungsod is in receipt of an indorsement dated April 24, 2008 from the Office of the City Mayor Eric C. Codilla of the aforementioned BAC Res. No. 2008-058 and further requested that the matter be treated as urgent considering that the project is one of the priorities of the city;

WHEREAS, the City Planning and Development Coordinator through an indorsement dated April 3, 2008 has requested that the herein referred project under BAC Res. No. 2008-058 be procured and implemented through negotiated contract in view of the justification presented by the consultant of the project and that the same will be in the best interest of the City Government if the same be awarded to the existing contractor per Government Guidelines;

WHEREAS, this august Body believes that said request is reasonable, hence, the same be accorded due course of action;



WHEREFORE, foregoing premises considered, on motion of City Councilor, Ruben R. Capahi, Chairman, Committee on Finance and Appropriation, jointly seconded by City Councilors Mariano Y. Corro and Sotero M. Pepito; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution APPROVING BIDS AND AWARDS COMMITTEE (BAC) RESOLUTION NO. 2008-058, ENTITLED, "A RESOLUTION RECOMMENDING THE ADDITIONAL PIPE LAYING OF THE TRANSMISSION OF SUB PROJECT SIX/ZONE 1B OF DISTRIBUTION MAINS REHABILITATION/IMPROVEMENT/EXPANSION OF THE ORMOC CITY WATERWORKS SYSTEM/PHASE 1B DEVELOPMENT OF WATER SYSTEM AT HERMOSILLA DRIVE, OSMEÑA EXT., AND AGUA DULCE TO BANTIGUE, ORMOC CITY BE UNDERTAKEN THROUGH A CONTRACT WITH THE SAME CONTRACTOR, PHILIPPINE NEGOTIATED CONSTRUCTION CORPORATION IN THE AMOUNT OF ONE MILLION SIX HUNDRED THIRTY FOUR THOUSAND EIGHT HUNDRED THIRTY FIVE & 44/100 (P1,634,835.44) PESOS ONLY" AND FURTHER AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN THE SAID NEGOTIATED CONTRACT FOR AND IN BEHALF OF THE CITY GOVERNMENT WITH THE PHILIPPINE RIGID CONSTRUCTION CORPORATION;
