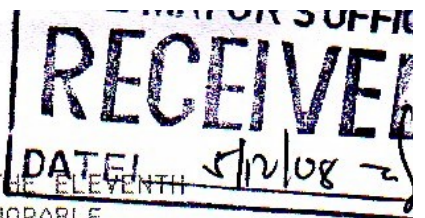

RESOLUTION NO. 2008-087

A RESOLUTION APPROVING BAC RESOLUTION NO. 2008-060, ENTITLED: "A RESOLUTION RECOMMENDING THAT THE ADDITIONAL APPROPRIATION FOR NEW ORMOC CITY HALL BUILDING AND LOCAL AREA NETWORK (LAN) STRUCTURED CABLING PROJECT - CONSTRUCTION OF NEW ORMOC CITY HALL BUILDING (PHASE IV-B) AT GOVERNMENT CENTER, AUNUBING "Y" STREET, ORMOC CITY BE UNDERTAKEN THROUGH A NEGOTIATED CONTRACT WITH THE SAME CONTRACTOR, PHILIPPINE RIGID CONSTRUCTION CORPORATION IN THE AMOUNT OF FOURTEEN MILLION ONE HUNDRED FIFTY SEVEN THOUSAND ONE HUNDRED FOURTEEN AND 47/100 (P14,157,114.47) PESOS ONLY" AND FURTHER AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN THE SAID NEGOTIATED CONTRACT.

WHEREAS, the Eleventh Sangguniang Panlungsod ng Ormoc is in receipt of an indorsement dated April 22, 2008 from the Honorable City Mayor Eric C. Codilla in connection with the aforementioned BAC Resolution No. 2008-060 and further requesting for authority to sign said Negotiated Contract for and in behalf of the City Government of Ormoc;

WHEREAS, the Technical Working Committee (TWC) headed by Engr. Raoul E. Cam, in a communication dated March 24, 2008 has recommended that the herein referred project under BAC Resolution No. 2008-060 be undertaken through a Negotiated Contract with the same contractor, PHILIPPINE RIGID CONSTRUCTION CORPORATION;

WHEREAS, said recommendation of the Technical Working Committee (TWC) was made considering that the said project is contiguous to the on-going scope of work at the New Ormoc City Hall Building which was being undertaken by the subject contractor who has shown exemplary contracting capacity and satisfactory performance in the course of their construction works;



WHEREAS, the City Treasurer, in a Certification dated April 10, 2008, certified that funds are available for the said project to be taken from out of the CY 2008 AIP (20% Dev't. Fund);

WHEREAS, this Sanggunian believes that the request is just and reasonable hence, the same necessitates immediate course of action;

WHEREFORE, foregoing premises considered on motion of City Councilor Ruben R. Capahi, Chairman, Committee on Finance and Appropriation, jointly seconded by City Councilors Mariano Y. Corro and Sotero M. Pepito; be it




