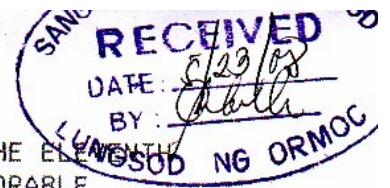

RESOLUTION NO. 2008-097

A RESOLUTION APPROVING ORDINANCE NO. 2008-002 OF THE BARANGAY COUNCIL OF BARANGAY GUINTIGUI-AN, THIS CITY, ENTITLED: "AN ORDINANCE AMENDING SOME PROVISIONS OF BARANGAY ORDINANCE NO. 01 SERIES OF 1992 "AN ORDINANCE PRESCRIBING THE RATES OF FEES AND CHARGES OF CLEARANCES ISSUED FOR SPECIFIC PURPOSE AND OTHER PURPOSE."

WHEREAS, this Sanggunian is in receipt of Barangay Ordinance No. 2008-008 of the Barangay Council of Barangay Guintigui-an entitled: "AN ORDINANCE AMENDING SOME PROVISIONS OF BARANGAY ORDINANCE NO. 01 SERIES OF 1992 "AN ORDINANCE PRESCRIBING THE RATES OF FEES AND CHARGES OF CLEARANCES ISSUED FOR SPECIFIC PURPOSE AND OTHER PURPOSE."

WHEREAS, the Sangguniang Panlungsod ng Ormoc, in relation to the aforecited ordinances at issue (and all other ordinances of the Sangguniang Barangay in Ormoc City) is, by law, granted the Power to review as to whether said ordinance is consistent with law and city x x x ordinances; (Sec. 57, 1991 LGC)


