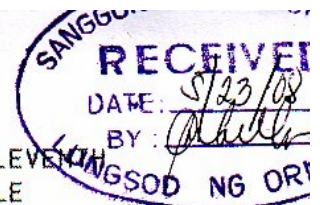

RESOLUTION NO. 2008-100

A RESOLUTION REQUESTING CONGRESS OF THE PHILIPPINES TO SUPPORT THE PROPOSED BILL AMENDING THE ELECTRIC POWER INDUSTRY REFORM ACT (EPIRA LAW), PROHIBITING MERALCO FROM PASSING ON TO CONSUMERS SYSTEM LOSS CHARGES, DISTRIBUTION CHARGES, UNIVERSAL CHARGES AND OTHER SIMILAR CHARGES THAT ARE PRACTICALLY DOUBLING THE COST OF THE CONSUMERS' ELECTRIC BILLS, AND TO INCLUDE IN THE COVERAGE ELECTRIC COOPERATIVES, AND OTHER ELECTRIC DISTRIBUTION FACILITIES, FURTHER, TO REQUEST OTHER PROVINCES, CITIES AND MUNICIPALITIES TO PASS ON SIMILAR RESOLUTIONS.

WHEREAS, aside from MERALCO, electric cooperatives and other electric distribution facilities are also passing on to consumers systems loss charges, distribution charges, universal charges and other similar charges thereby doubling the cost of the consumers' electric bills;

WHEREAS, these passed-on charges albeit allowed under the Electric Power Industry Reform Act (EPIRA LAW) are additional burden to electric consumers;

WHEREAS, this Sangguniang Panlungsod believes that this pending proposal in Congress to amend existing EPIRA LAW (not to allow MERALCO to pass on these charges) should also include electric cooperatives and all electric distributions utilities;

WHEREFORE, foregoing premises considered, on MASS MOTION of the Body; be it




