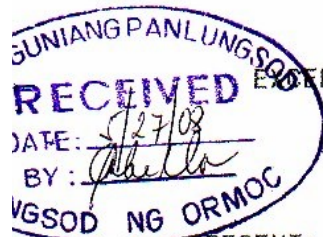

RESOLUTION NO. 2008-102

A RESOLUTION REQUESTING THE HEAD OF THE BUREAU OF FIRE PROTECTION, FIRE CHIEF SUPERINTENDENT ENRIQUE LINSANGAN TO GIVE FOUR (4) FIRE TRUCKS AND TWO (2) TRAUMA VANS/AMBULANCES TO ORMOC CITY FOR THE USE OF THE ORMOC CITY FIRE DEPARTMENT AND THE LATTER TO BE MANNED/OPERATED BY THE ORMOC FIRE DEPARTMENT AND THE ORGANIZED RESCUERS AND MEDICAL-AIDES OF ORMOC FIRE DEPARTMENT AND THE ORGANIZED RESCUERS AND MEDICAL-AIDES OF ORMOC CITY (O.R.M.O.C.), THE MEMBERSHIP OF WHICH IS COMPOSED OF OCFD, OCPD, RED CROSS AND CIVILIAN PERSONNEL OF THE LGU-ORMOC.

WHEREAS, there is a communication coming from the City Mayor requesting the Sangguniang Panlungsod to pass a resolution asking the Bureau of Fire Protection Central Office to allocate and give four (4) fire trucks and two (2) trauma vans for Ormoc City;

WHEREAS, Ormoc City is in need of these fire trucks and trauma vans considering the rapid growth of population and increase of business establishments;

WHEREAS, these requested fire trucks and trauma vans will serve the needs for quick response both for fire suppression and public safety not only for Ormoc City itself but would also assist the neighboring barangays;

WHEREAS, Ormoc City has trained personnel for emergency response and this group is called Organized Rescuer's & Medical-Aides;

WHEREAS, the Organized Rescuers and Medical-Aides of Ormoc City (O.R.M.O.C.) is composed of personnel from Ormoc City Fire Department (OCFD), Ormoc City Police Department (OCPD), Philippine National Red Cross (PNRC) - Ormoc Chapter, and civilian personnel from the local government unit;



WHEREAS, this sanggunian believes that this resolution is appropriate, proper and of prime importance for the protection of Ormoc City and its constituents;

WHEREFORE, FOREGOING PREMISES CONSIDERED, on MASS MOTION of the Body; be it




