RESOLUTION NO. 2008-106

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO SIGN THE MEMORANDUM OF AGREEMENT (MOA) FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC, WHICH MEMORANDUM OF AGREEMENT IS AMONG THE DEPARTMENT OF ENERGY (DOE), NATIONAL POWER CORPORATION (NPC) AND LOCAL GOVERNMENT UNIT OF ORMOC.

WHEREAS, this Sanggunian is in receipt of an urgent indorsement dated May 27, 2008 from the Honorable City Mayor Eric C. Codilla, requesting for authority to sign the proposed Memorandum of Agreement (MOA), in behalf of the Local Government Unit of Ormoc, with the aforementioned parties;

WHEREAS, said Memorandum of Agreement refers to the implementation of the proposed projects which were submitted by the city government to the Department of Energy and duly endorsed by NPC-IPPCM Visayas to be funded out of the financial benefits under Energy Regulations (E.R.) No. 1-94, as amended, and hereby identified as follows:

1. Purchase of One (1) Unit Garbage Compactor	- P6,215,000.00
2. Concrete Sanitary Run-Off Facility with concrete Pavement:	
a. For Brgy. Bagong	- 1,000,000.00
b. For Brgy. Lake Danao	- 2,000,000.00

WHEREAS, the Memorandum of Agreement further mentioned that the Department of Energy, through Notices to Proceed (NTP) Nos. RWMHEEF2008-013 and RWMHEEF2008-014 has appropriated the amount of NINE MILLION TWO HUNDRED FIFTEEN THOUSAND PESOS (P9,215,000.00) for the implementation of the afore-enumerated projects, funding of which was taken from the department-administered trust account for Reforestation, Watershed Management, Health and/or Environment Enhancement Fund (RWMHEEF) accruing from the commercial operation of Leyte-Cebu Interconnection Project;

WHEREAS, this august Body find the provisions of the Memorandum of Agreement as just and reasonable and the said projects to be implemented being beneficial to the city, hence, the request of the Honorable City Mayor deserves due course of action;

WHEREFORE, foregoing premises considered, on motion of City Councilor Mariano Y. Corro, Chairman, Committee on Energy Conservation, severally seconded by City Councilors Claudio P. Larrazabal, Sotero M. Pepito and Ruben R. Capahi; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO SIGN THE MEMORANDUM OF AGREEMENT (MOA) FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC, WHICH MEMORANDUM OF AGREEMENT IS AMONG THE DEPARTMENT OF ENERGY (DOE), NATIONAL POWER CORPORATION (NPC) AND LOCAL GOVERNMENT UNIT OF ORMOC;


ADOPTED, May 29, 2008.
