RESOLUTION NO. 2008-108

A RESOLUTION REQUESTING MS. VICENTA C. ALIBANGBANG
SCHOOLS DIVISION SUPERINTENDENT, ORMOC CITY DIVISION TO
OPEN AN EXTENSION GRADE ONE CLASS IN BARANGAY MABATO,
ORMOC CITY, SY 2008-2009..

WHEREAS, the 11th Sangguniang Panlungsod received a Barangay
Council Resolution # S-2008 from Barangay Mabato, this city dated March
2, 2008 requesting the Hon. City Mayor, Engr. Eric C. Codilla to open a
grade one class in the said barangay;

WHEREAS, the power/authority to establish an Elementary School is
vested in the Office of the School Division Superintendent, hence this
resolution;

WHEREAS, Section I, Article XIV of the 1987 Philippine Constitution
mandated that, "The State shall . . . promote the right of all citizens
to quality education at all levels and shall take appropriate steps to
make such education accessible to all". (underscoring supplied);

WHEREAS, the opening of a grade one class in Barangay Mabato will
provide the 6-year old population of said barangay easier access to
education, hence, will give life and meaning to the above cited
provision of the constitution;

WHEREAS, the number of 6-Year Old Children of Barangay Mabato is
enough to warrant the opening of one solid grade one class with a
teacher - pupil ratio of 1:40, thus, satisfying the basic requirement
prescribed by the Department of Education;

WHEREAS, Barangay Mabato had already acquired the school site with
one-room school building that can accommodate the proposed grade one
class, once it is opened on June 9, 2008;

WHEREAS, it is too risky for the 6-Year Old school children to walk/travel a distance of approximately 8 kms. a day just to be able to study in neighboring schools;

WHEREFORE, FOREGOING PREMISES CONSIDERED, on motion of City Councilor Filomeno P. Maglasang, Chairman, Committee on Education, severally seconded by City Councilors Mariano Y. Corro, Sotero M. Pepito and Fe S. Lladoc; be it


