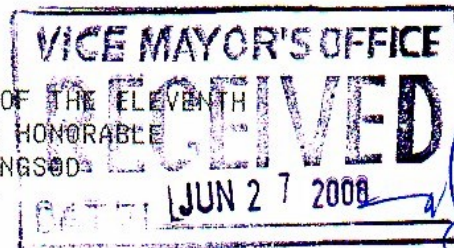

RESOLUTION NO. 2008-117

A RESOLUTION APPROVING ORDINANCE NO. 2008-002 OF THE BARANGAY COUNCIL OF BARANGAY COGON, THIS CITY, ENTITLED: "AN ORDINANCE PROHIBITING THE RESIDENTS OF THIS BARANGAY FROM THE INDISCRIMINATE THROWING OF GARBAGE, AND/OR THE UNSANITARY DISPOSAL OF ANY WASTE MATERIALS, AND PROVIDING PENALTIES THEREOF."

WHEREAS, this Sanggunian is in receipt of Barangay Ordinance No. 2008-002 of the Barangay Council of Barangay Cogon, this city, entitled: "AN ORDINANCE PROHIBITING THE RESIDENTS OF THIS BARANGAY FROM THE INDISCRIMINATE THROWING OF GARBAGE, AND/OR THE UNSANITARY DISPOSAL OF ANY WASTE MATERIALS, AND PROVIDING PENALTIES THEREOF.";

WHEREAS, the Sangguniang Panlungsod ng Ormoc, in relation to the aforecited ordinance at issue (and all other ordinances of the Sangguniang Barangay in Ormoc City) is, by law, granted the Power to review as to whether said ordinance is consistent with law and city x x x ordinances; (Sec. 57, a991 LGC);

WHEREAS, it is the observation of this august Body that the said ordinance has conformed to the pertinent provisions of the Local Government Code, hence, reasonable and within the province of Sangguniang Barangay of Cogon to legislate;

WHEREFORE, foregoing premises considered, on motion of City Councilor Demosthenes F. Tugonon, Chairman, Committee on Laws and Ordinances, jointly seconded by City Councilor Mariano Y. Corro and Sotero M. Pepito; be it


ADOPTED, June 26, 2008
