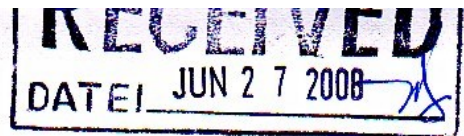

RESOLUTION NO. 2008-122

A RESOLUTION EXPRESSING ACKNOWLEDGEMENT AND GRATITUDE TO  
PHILIPPINE ASSOCIATED SMELTING PLANT AND REFINING  
CORPORATION (PASAR) FOR THE IMMEDIATE AND GENEROUS  
REACTION IN HELPING COMMUNITIES IN ORMOC AFFECTED BY  
TYPHOON FRANK ON JUNE 20, 2008.

WHEREAS, on June 20, 2008 up to the early morning of June 21, the  
City of Ormoc and the surrounding barangays were battered by typhoon  
Frank;

WHEREAS, due to this typhoon, several barangays were in immediate  
need of food items and relief;

WHEREAS, the Ormoc City government extended assistance to barangays  
and people directly affected and in urgent need of food supplies;

WHEREAS, the Philippine Associated Smelting and Refining  
Corporation (PASAR) and its corporate officials, thru its president, Mr.  
Louis Hosea Els, without hesitation and afterthought gave assistance  
liberally to the City of Ormoc;

WHEREAS, PASAR was assigned to barangays namely: Licuma, Labrador,

distributed food items to their assigned barangays in the total amount
