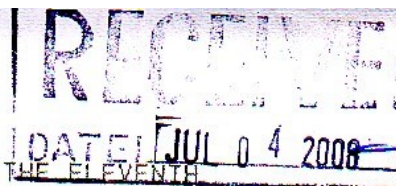

TUGONON TO ASSIST OUR CITY LEGAL OFFICER DESIGNATE IN CASE NO. G.R. SP. 03324, ENTITLED: "LIDE MANAGEMENT CORPORATION, PETITIONER, VERSUS CITY OF ORMOC, LEYTE, HON. ERIC C. CODILLA, ET AL., RESPONDENTS, PENDING WITH THE COURT OF APPEALS, CEBU CITY.

WHEREAS, the City is the respondent in a case before the Court of Appeals, Cebu City, docketed as G.R. SP No. 03324 entitled "LIDE Management Corporation vs. City of Ormoc, Leyte, Hon. Eric C. Codilla, Et Al.;

WHEREAS, the Honorable City Mayor Eric C. Codilla has issued Executive Order No. 12, S. 2008 dated June 6, 2008 creating a committee to represent the City Government of Ormoc to the LMC Case in consideration of the request of the Acting City Legal Officer, Atty. James Clinton C. Nuevo, this city, for assistance to handle said case;
