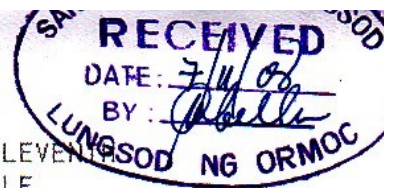

ORMOC CITY;





