## RESOLUTION NO. 2008-136

A RESOLUTION AUTHORIXING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO NEGOTIATE A LOAN FOR AND BEHALF OF THE CITY GOVERNMENT OF ORMOC WITH LAND BANK OF THE PHILIPPINES AGAINST INTERNAL REVENUE ALLOTMENT RECEIVABLE SUPPORTED BY THE NOTICE OF PAYMENT SCHEOULE (NPS) TO BE USED TO FINANCE THE IMPLEMENTATION OF PRIORITY PROJECTS IN NEED OF ADDITIONAL FUNDING.

WHEREAS, this Sanggunian is in receipt of a letter dated July 01, 2008 from the Honorable City Mayor Eric C. Codilla urgently requesting for the passage of a resolution authorizing Him to negotiate a loan with Land Bank of the Philippines against Internal Revenue Allotment Receivable supported by the Notice of Payment Schedule (NPS) to be used to finance the implementation of priority projects in need of additional funding;

WHEREAS, the Honorable Secretary, Department of Budget and Management through a Notice of Payment Schedule dated May 16, 2008 has stated that Pursuant to Executive Order No. 723, said Notice is issued to inform the City of its share in the Internal Revenue Allotment (IRA) differential for FYs 2001 and 2004 corresponding to the difference between the IRA level reflected in the National Expenditure Program (NEP) and the amount released under the re-enacted budgets for said budget years. This amount shall be paid in seven (7) equal installments, as follows:
