A RESOLUTION RESPECTFULLY REQUESTING HONORABLE EUFROCINO M. CODILLA, SR., REPRESENTATIVE, FOURTH DISTRICT OF LEYTE, FOR FINANCIAL ASSISTANCE IN THE AMOUNT OF TWENTY MILLION PESOS (P20,000,000.00) TO BE USED IN THE CONSTRUCTION OF THE ORMOC DIVERSION ROAD AND FOR FINANCIAL ASSISTANCE FOR FARMERS IN THE CITY ADVERSELY AFFECTED BY TYPHOON "FRANK".

WHEREAS, the City Government of Ormoc is planning to construct a diversion road to help ease the traffic congestion in the city due to the increasing volume of vehicles travelling in and out of Ormoc City;

WHEREAS, this problem has been experienced by the City of Ormoc for quite sometime now and that giving solution to it is indeed necessary for safety and smooth flow of traffic;

WHEREAS, as a growing City, Ormoc has priority projects to attend to and one of which is the need for the construction of a diversion road which will hopefully materialize with adequate funding, hence, this request;

WHEREAS, Typhoon "Frank" wrought havoc in the City of Ormoc when it struck last June 20 and 21, 2008;

WHEREAS, numerous farmers in the City of Ormoc were adversely affected by the said typhoon;

WHEREFORE, foregoing premises considered, on motion of City Councilor Ruben R. Capahi, Chairman, Committee on Finance & Appropriations, severally seconded by City Councilors Mariano Y. Corro, Claudio P. Larrazabal and Sotero M. Pepito; be it
