

RESOLUTION NO. 2008-140

A RESOLUTION PROPOSING MINOR AMENDMENTS TO HOUSE BILL NO. _____, ENTITLED: "AN ACT SEPARATING THE EASTERN VISAYAS STATE UNIVERSITY - ORMOC CITY SCHOOL OF ARTS AND TRADE IN BARANGAY DON FELIPE LARRAZABAL, ORMOC CITY FROM THE EASTERN VISAYAS STATE UNIVERSITY IN TACLOBAN CITY, BOTH LOCATED IN THE ISLAND OF LEYTE, CONVERTING IT INTO A STATE COLLEGE TO BE KNOWN AS THE ORMOC CITY STATE COLLEGE AND APPROPRIATING FUNDS THEREFOR.

WHEREAS, this Sanggunian is fully aware that there is a present move in the House of Representatives for the enactment of House Bill No. _____ (In substitution to HB No. 1755), entitled: "AN ACT SEPARATING THE EASTERN VISAYAS STATE UNIVERSITY - ORMOC CITY SCHOOL OF ARTS AND TRADE IN BARANGAY DON FELIPE LARRAZABAL, ORMOC CITY FROM THE EASTERN VISAYAS STATE UNIVERSITY IN TACLOBAN CITY, BOTH LOCATED IN THE ISLAND OF LEYTE, CONVERTING IT INTO A STATE COLLEGE TO BE KNOWN AS THE ORMOC CITY STATE COLLEGE AND APPROPRIATING FUNDS THEREFOR", said House Bill is introduced by Reps. Eufrocino M. Codilla, Sr., Cynthia A. Villar, Edcel C. Lagman, Exequiel B. Javier and Jesus Crispin C. Remulla;

WHEREAS, in a letter dated January 29, 2008 the Hon. Cynthia A. Villar, Chairperson, Committee on Higher & Technical Education (CHTE) has informed the Hon. Eufrocino M. Codilla, Sr., Representative of the 4th District of Leyte, that subject House Bill No. _____ which is a substitute bill to House Bill No. 1755, will be adopted by the CHTE for referral both to the House Committees on Appropriations and Ways and Means for comments on the appropriations provision and tax exemption provision, as a matter of procedure, prior to the preparation of committee report;

WHEREAS, as a matter of coordination with the LGU of Ormoc City, the aforementioned House Bill is brought up before this august Body for conformity as regards to the extent and future complications of its entire provisions;

WHEREAS, after careful study and thorough deliberation of the matter, the Honorable Members of the Eleventh Sangguniang Panlungsod ng Ormoc hereunder present the following proposed amendments to the aforementioned House Bill, to wit:

- (1) On the title of the House Bill:
 - in the phrase "BOTH LOCATED IN THE PROVINCE OF LEYTE" the word PROVINCE be deleted and changed to ISLAND;
- (2) On Lines 13 and 14 of Page 1:
 - insert the phrase "City of Ormoc" before the phrase "Province of Leyte";
- (3) Lines 15, 16 and 17 of Page 1 shall be entirely deleted;
- (4) On Line 1 of Page 2:
 - the phrase "their high school education" be deleted;
- (5) On Line 24 of Page 2:
 - the phrase "Province of Leyte" be deleted and changed to "City of Ormoc";
- (6) On Lines 11 and 12 of Page 6:
 - the phrase "Provided, That in order to effect a smooth transition to a state college, the incumbent head of the EVSU-OCSAT, shall serve as the first President of the College" be rephrased as follows:
"Provided, that in order to effect a smooth transition to a state college, the Board shall immediately constitute the Search Committee for the Presidency and pending the appointment of a new President, the incumbent head of the EVSU-OCSAT, if qualified, shall serve as Officer in Charge for six (6) months only;
- (7) On Line 37 of Page 7:
 - after the phrase "shall be titled under that name" shall be inserted the following: "except the Don Felipe Larrazabal campus owned by the Ormoc City National High School before its conversion into Ormoc City School of Arts and Trade (OCSAT) which campus shall be reverted to the Ormoc City National High School Provided, the College may continue occupancy in the campus of the former for a period of two (2) years only from the time of approval of this law creating the Ormoc City State College";

WHEREFORE, foregoing premises considered, on motion of City Councilor Filomeno P. Maglasang, Chairman, Committee on Education, severally seconded by City Councilors Jose C. Alfaro, Jr., Rafael C. Omega, Jr. and Fernando P. Parrilla; be it

RESOLVED, as it is hereby resolved, to pass a resolution PROPOSING MINOR AMENDMENTS TO HOUSE BILL NO. ____, ENTITLED: "AN ACT SEPARATING THE EASTERN VISAYAS STATE UNIVERSITY - ORMOC CITY SCHOOL OF ARTS AND TRADE IN BARANGAY DON FELIPE LARRAZABAL, ORMOC CITY FROM THE EASTERN VISAYAS STATE UNIVERSITY IN TACLOBAN CITY, BOTH LOCATED IN THE ISLAND OF LEYTE, CONVERTING IT INTO A STATE COLLEGE TO BE KNOWN AS THE ORMOC CITY STATE COLLEGE AND APPROPRIATING FUNDS THEREFOR;


