RESOLUTION NO.

A RESOLUTION AUTHORIZING THE CITY BUDGET OFFICER TO RELBASE THE AMOUNT OF SIX HUNDRED THIRTY-NINE THOUSAND NUNDRED PESOS ONLY (\$239,900.00) FOR THE PAYMENT OF ROOD SUPPLIES DISTRIBUTED IN FORM OF RELIEF AND ASSISTANCE TO VICTIMS OF TYPHOON FRANK AND THE AMOUNT OF EIGHTY-FIVE THOUSAND FOUR HUNDRED SEVENTY-EIGHT PESOS AND SIXIY-TWO CENTAVOS (\$\frac{1}{2}85,478.62) FOR THE (₱85,478.62) FOR THE PAYMENT OF FUEL USED DURING THE PRE-TYPHOON AND POST-OPERATIONS TOTALLING TO SEVEN HUNDRED TWENTY-TYPHOON FIVE THOUSAND THREE HUNDRED SEVENTY-EIGHT PESOS AND SIXTY-TWO CENTAVOS (₱725,378.62).

WEEREAS, in accordance with the rules and regulations implementing Republic Act 8185 an Act amending section 324 (d) of Republic Act 7160 otherwise known as the Local Government Code of 1991 Section 6 entitled Procedural Guidelines paragraph b "The allotment from the 5% calamity fund shall be released by the Local Budget Officer within twenty-four (24) hours from the occurrence of the calamity upon presentation of disbursement vouchers duly approved by the authorities concerned and supported by Sanggunian Resolution and LDCC estimates based on surveys of the extent of damages";

WHEREAS, it is a known fact that typhoon Frank passed by Ormoc City and caused damage and destruction to many private residences and agricultural livelihood in the community;

WHEREAS, on the day and night during the typhoon, clearing operation team from the Ormoc General Services Office and members of the Organized Rescuers and Medical Aides of Ormoc City (O.R.M.O.C.) were on stand by and have rescued more or less twenty-five (25) persons who were stranded in the flood and conducted clearing operations of the main highways of Ormoc thus making it immediately passable as early as five o'clock in the morning;



WHEREAS, the following day immediately after the typhoon, the Local Government of Ormoc through the CDCC headed by the Honorable City Mayor, distributed relief goods to typhoon victims located in several barangays affected;

WHEREAS, all these activities incurred a lot of expenses which is authorized to be taken from the calamity fund as also provided by Republic Act 8185 Section 5 paragraph B.1 - Usage of the 5% Calamity Fund - "The Calamity Fund shall be utilized for the relief, reconstruction, rehabilitation, and other works or services in connection with the calamities which may occur during the budget year. Provided, that such fund shall be used/utilized only in the area of the LGU affected by the disaster or calamity as determined and declared under the state of calamity by the Sanggunian concerned by way of a resolution";

WHEREAS, in the Joint DBM-DILG Memorandum of Circular 2003-1 dated March 20, 2003 which says among others x x x said "appropriation may be validly used for relief, rehabilitation, reconstruction, and other works or services in connection with man-made disasters resulting from unlawful acts of insurgents, terrorists and other criminals as well as for disaster preparedness and other pre-disaster activities;

WHEREAS, on July 24, 2003 Joint DEM-DILG Memorandum Circular No. 2003 further clarifies that "the 5% Local Calamity Fund for every Local Government Unit shall be utilized only for relief, reconstruction, rehabilitation and other works and services, in connection with a calamity which occurred during the budget year. Under the aforesaid Act, calamity has been defined as a state of extreme distress or great misfortune caused by adverse event or natural force, causing widespread loss or extensive damage to livestocks, lives, crops and properties";

WHEREAS, the fourteen (14) barangays passed a resolution requesting the City Government of Ormoc through the City Disaster Coordinating Council (CDCC) for relief assistance to be extended to affected residents in our barangay due to "Typhoon Frank";

WHEREAS, this Sangguniang Panlungsod believes that the move is in accordance with the existing laws and regulations pertaining to the utilization of the city's calamity fund;

NOW THEREFORE, on motion of City Councilor Jose C. Alfaro, Jr., CDCC Action Officer, jointly seconded by City Councilors Fernando P. Parrilla and Sotero M. Pepito; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution AUTHORIZING THE CITY BUDGET OFFICER TO RELEASE THE AMOUNT OF SIX HUNDRED THIRTY-NINE THOUSAND NINE HUNDRED PESOS ONLY (\$\mathbb{P}639,900.00) FOR THE PAYMENT OF FOOD SUPPLIES DISTRIBUTED IN FORM OF RELIEF AND ASSISTANCE TO VICTIMS OF TYPHOON FRANK AND THE AMOUNT OF EIGHTY-FIVE THOUSAND FOUR HUNDRED SEVENTY-EIGHT PESOS AND SIXTY-TWO CENTAVOS (\$\mathbb{P}85,478.62) FOR THE PAYMENT OF FUEL USED DURING THE PRE-TYPHOON AND POST-TYPHOON OPERATIONS TOTALLING TO SEVEN HUNDRED TWENTY-FIVE THOUSAND THREE HUNDRED SEVENTY-EIGHT PESOS AND SIXTY-TWO CENTAVOS (\$\mathbb{P}725,378.62);

ADOPTED, July 24, 2008.
