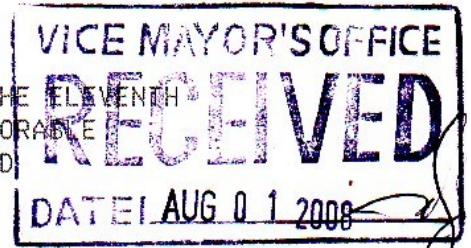

Councilor Claudio P. Larrazabal and Sotero M. Pepito: be it

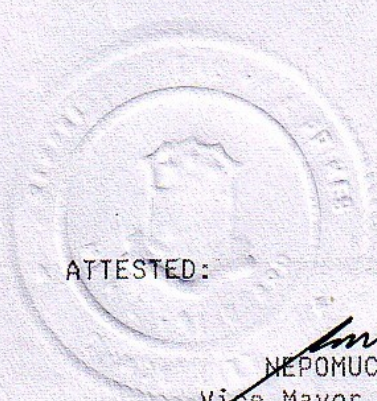
RESOLVED, AS IT IS HEREBY RESOLVED, to pass a RESOLUTION DECLARING

ADOPTED, July 31, 2008.


RESOLVED, FURTHER, to furnish copies of this resolution each to His

Chairmen/Treasurers of the barangay concerned, -all in Ormoc City;


