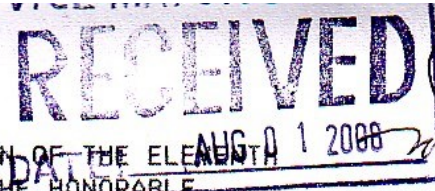

RESOLUTION NO. 2008-148

A RESOLUTION AUTHORIZING THE CITY ACCOUNTANT TO CHARGE THE AMOUNT OF FIFTEEN THOUSAND PESOS (P15,000.00) AGAINST THE NON-OFFICE ACCOUNT - PROVISION FOR PRIOR YEAR'S OBLIGATION - OF THE CY 2008 ANNUAL BUDGET FOR THE PAYMENT OF EXTRA CASH GIFT OF RONALD V. NEPOMUCENO FOR CY 2007.

WHEREAS, this Sanggunian is in receipt of 1st Indorsement dated July 01, 2008 from the Office of the City Mayor relative to the herein letter request of Dr. Amando P. Apoderado, City Veterinarian, for a supplemental appropriation in the amount of FIFTEEN THOUSAND PESOS (P15,000.00) for the additional Cash Gift of Ronald V. Nepomuceno;

WHEREAS, Ronald V. Nepomuceno who holds the position of Meat Inspector II of the Veterinary Services Office, was not able to collect the additional cash gift last December 2007 as he was on leave for six (6) months because of the illness of his wife;

WHEREAS, the Office of the City Budget Officer through 2nd Indorsement dated July 09, 2008 has recommended that authority be granted to the City Accountant thru an SP resolution, to charge above obligation against the non-office account - Provision for Prior Year's Obligation - of the CY 2008 Annual Budget;

FURTHERMORE, the City Treasurer, in an Indorsement dated July 21, 2008 also recommended that said payment be charged to Provision for Prior Year's Obligation of the 2008 Annual Budget which funds are duly certified as available provided that the city accountant, this city, be authorized to charge to said account through a Sangguniang Panlungsod Resolution;

WHEREFORE, foregoing premises considered, on motion of City Councilor Ruben R. Capahi, Chairman, Committee on Finance, jointly seconded by City Councilors Mariano Y. Corro and Claudio P. Larrazabal; be it
