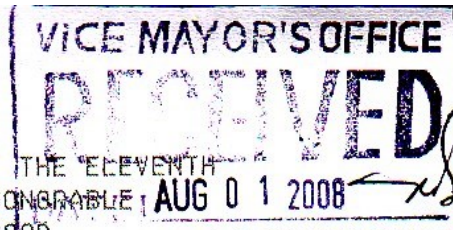

RESOLUTION NO. 2008-150

A RESOLUTION AUTHORIZING THE LIGA NG MGA BARANGAY - ORMOC
CHAPTER TO OPERATE AND MANAGE A ROLLING STORE OF
NATIONAL FOOD AUTHORITY (NFA).

WHEREAS, this Sanggunian is in receipt of Resolution No. 14, Series
of 2008 of the Liga ng mga Barangay, this city, entitled: "A RESOLUTION
REQUESTING THE NATIONAL FOOD AUTHORITY (NFA) TO ACCREDIT AND ALLOW THE
LIGA NG MGA BARANGAY, ORMOC CHAPTER TO OPERATE A ROLLING STORE OF THE
BIGASAN NG BAYAN";

WHEREAS, said resolution was made in response to the sentiments
expressed by the respective Punong Barangay within Ormoc City regarding

the NFA Rice Program of the City Government;


