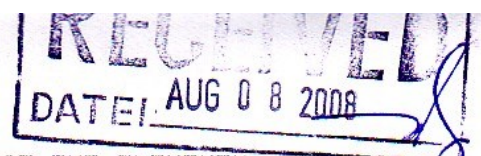

A RESOLUTION RESPECTFULLY REQUESTING HONORABLE EUFROCINO M. CODILLA, SR., REPRESENTATIVE, FOURTH DISTRICT OF LEYTE, FOR FINANCIAL ASSISTANCE IN THE AMOUNT OF TEN MILLION PESOS (P10,000,000.00) FOR THE FARMERS IN THE CITY OF ORMOC WHICH WERE ADVERSELY AFFECTED BY TYPHOON FRANK.

WHEREAS, Typhoon Frank wrought havoc in the City of Ormoc when it struck last June 20 and 21, 2008;

This Resolution supersedes and revokes Resolution No. 2008-137 dated July 16, 2008;




