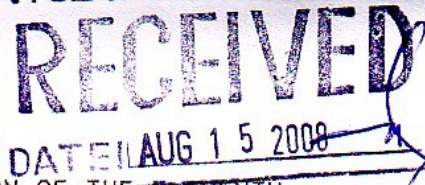

RESOLUTION NO. 2008-156

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT (MOA) BETWEEN THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH) AND THE LOCAL GOVERNMENT UNIT OF ORMOC CITY FOR THE IMPLEMENTATION OF THE SPECIAL ROAD FUND (SLRF) UNDER R.A. 8794 OR THE MOTOR VEHICLE USERS' CHARGE (MVUC) LAW.

WHEREAS, this sanggunian is in receipt of an indorsement dated August 1, 2008 from the Honorable City Mayor Eric C. Codilla, requesting for authority to sign the Memorandum of Agreement (MOA) between the Department of Public Works and Highways and the Local Government Unit of Ormoc City for the implementation of the Special Road Fund (SLRF) under R.A. 8794 or the Motor Vehicle Users' Charge (MVUC) Law;

WHEREAS, said agreement refers to the release, utilization and liquidation of funds for the eligible projects and activities of the LGU such as road maintenance, road safety devices and traffic management funded by the Special Local Road Fund to be implemented by LGUs in accordance with the policies, standards and procedures of R.A. 8794 (MVUC Law) and its Implementing Rules and Regulations (IRR);

WHEREAS, this august Body believes that said request is just and reasonable, hence, the same be accorded due course of action;

WHEREFORE, foregoing premises, considered on motion of City Councilor Claudio P. Larrazabal, Chairman, Committee on Infrastructure, duly seconded by City Councilors Sotero M. Pepito; be it


ADOPTED, August 14, 2008.
