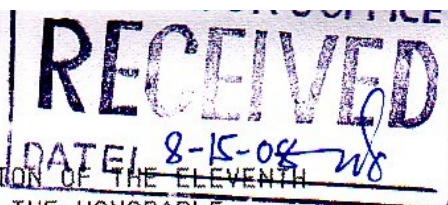

RESOLUTION NO. 2008-160

A RESOLUTION REQUESTING THE HONORABLE CARLOS JERICO L. PETILLA, GOVERNOR, PROVINCE OF LEYTE, FOR THE TRANSFER OF THE LEYTE PROVINCIAL JAIL FROM ORMOC CITY TO ANY MUNICIPALITY WITHIN THE PROVINCE OF LEYTE.

WHEREAS, the Leyte Provincial Jail has been in Ormoc City for some time now and is occupying a lot owned by the City;

WHEREAS, having been situated in an area closely occupied by New Ormoc City National High School (NOCNHS), Eastern Visayas State University (EVSU), other private schools, government offices, and the new City Hall of Ormoc, the Leyte Provincial Jail poses risk to the lives and properties of those people in the aforementioned establishments incase of a possible jail break;

WHEREAS, at present the city is in urgent need of the lot occupied by the Provincial Jail;

WHEREAS, for security purposes, this august Body deems it reasonable and just to relocate the said Leyte Provincial Jail as a risk reduction measure and/or prevention of harm that may be suffered by residents in the said area;

WHEREFORE, foregoing premises considered, on motion of City Councilor Demosthenes F. Tugonon, Chairman, Committee on Police, Fire and Penology, severally seconded by City Councilors Jose C. Alfaro, Jr., Fernando P. Parrilla and Sotero M. Pepito; be it




