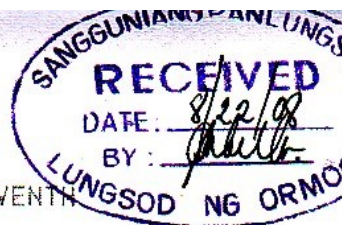

ADOPTED, August 24, 2008.


RESOLVED, FURTHER, to furnish copies of this resolution each to His

Chairman/Treasurer of the barangay concerned, -all in Ormoc City;


