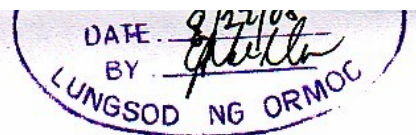

A RESOLUTION AUTHORIZING THE CITY ACCOUNTANT TO CHARGE
AGAINST CURRENT APPROPRIATION - OFFICE SUPPLIES - OF
THE GENERAL SERVICES OFFICE THE UNSETTLED ACCOUNT FOR
NEWSPAPER SUBSCRIPTION IN THE AMOUNT OF THREE THOUSAND
ONE HUNDRED TWENTY FIVE PESOS (P3,125.00) FOR THE
PERIOD FROM JULY TO DECEMBER 2007.

WHEREAS, this Sanggunian is in receipt of 1st Indorsement dated
August 12, 2008 from the Office of the City Mayor relative to the letter
request of Engr. Domardoni C. Cayanong, City General Services Officer
regarding the unsettled account for newspaper subscription for the
period from July - December 2007 and that authority be granted through a
Sangguniang Panlungsod Resolution;

WHEREAS, the City Budget Officer through an indorsement dated
August 19, 2008 has reiterated that authority be granted to the City
Accountant to charge the obligation against current appropriation -
Office Supplies - of said office;

FURTHERMORE, the City Treasurer in an Indorsement dated August
August 20, 2008 has certified that said amount is available subject of
the usual auditing and accounting procedures;

FOR NEWSPAPER SUBSCRIPTION IN THE AMOUNT OF THREE THOUSAND ONE HUNDRED
TWENTY FIVE PESOS (P3,125.00) FOR THE PERIOD FROM JULY TO DECEMBER 2007;
