WHEREAS, the late Vice Mayor Benjamin F. Tugonon was a dedicated public official of the city for a period of 30 years and has been known to be a hard working man who had greatly helped in bringing the City of Ormoc to its present status being a peaceful and financially stable city;

WHEREAS, reckoning back to his services as a public servant, he was a Practicing Lawyer by profession and became City Councilor in succession from January, 1963 to December, 1967 and from July, 1981 to October, 1981 respectively, became Acting City Vice Mayor & Presiding Officer of the 2nd Sangguniang Panlungsod ng Ormoc in succession from December, 1984 to May 1986; elected City Councilor of the Fifth Sangguniang Panlungsod ng Ormoc from 1988 to 1992; and elected Vice Mayor and Presiding Officer of the Sixth and Seventh Sangguniang Panlungsod ng Ormoc respectively, from 1992 to 1998, all with much sincerity and devotion;

WHEREAS, "BEN" as he was fondly called, was a public official you can depend on, an active member of various religious, civic and professional organizations, and was a recipient of many awards and recognition for his invaluable services to the Ormocanons;



WHEREAS, this august Body feels the irreparable loss of a conscientious, peace loving worker and friend who for a good number of years has dedicated his life to the government service and this Body likewise, shares the intense pain and sorrow of his death with his devoted wife, Dr. Alicia R. Tugonon, his children, Albenya Portia, Geraldine Tanya and Benedict, as well as that of his brothers and other relatives;
