Councilors Fernando P. Parrilla and Ruben R. Capahi; be it

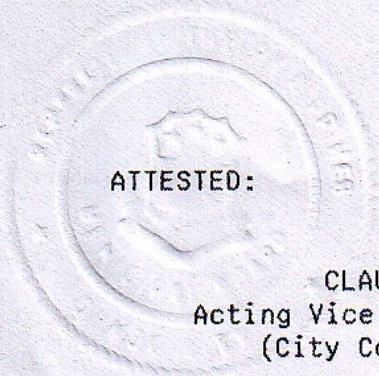
RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution APPROVING
