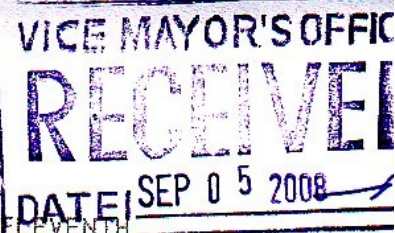

3. BARANGAY BILIBOY


