A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) BETWEEN THE CITY GOVERNMENT OF ORMOC AND SAN LORENZO RUIZ COLLEGE OF ORMOC (SLC-O) REPRESENTED BY ITS ADMINISTRATOR DR. ADELINA Y. LARRAZABAL.

WHEREAS, this Sanggunian is in receipt of 2nd Indorsement dated July 31, 2008 from the Hon. City Mayor Eric C. Codilla, requesting for authority to sign the Memorandum of Agreement (MOA) between the City Government of Ormoc and San Lorenzo Ruiz College of Ormoc on the affiliation of the said school's Bachelor of Science in Medical Technology students in the different Health Care and Laboratory Facilities at different District Health Centers of the Ormoc City Health Department;

WHEREAS, said request jibes with the program of the City of Ormoc to decentralize the health services by establishing five (5) health centers throughout the city;

WHEREAS, it is to the best interest of the city that students who are preparing for a life of service in the medical field are given access to available facilities to enhance their knowledge, skills and attitudes;

WHEREAS, the said Memorandum of Agreement also stipulates the specific obligation of the parties, under the terms and conditions agreed upon;

WHEREAS, this august Body believes that the terms and conditions of the Memorandum of Agreement are reasonable, hence, the same be accorded the necessary due course of action.


