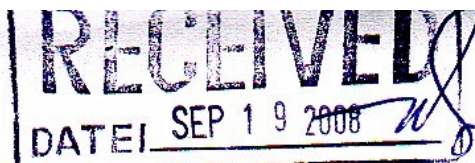

RESOLUTION NO. 2008-179

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO SIGN THE MEMORANDUM OF AGREEMENT (MOA) IN BEHALF OF THE CITY OF ORMOC WITH THE HONORABLE EUFROCINO M. CODILLA, SR., REPRESENTATIVE, 4TH DISTRICT OF LEYTE FOR THE ALLOCATION OF SEVEN MILLION FIVE HUNDRED THOUSAND PESOS (P7,500,000.00) OUT OF HIS CONGRESSIONAL FUNDS AS FINANCIAL ASSISTANCE TO THE CITY OF ORMOC FOR THE PROMOTION OF HEALTH.

WHEREAS, this august Body is in receipt of an indorsement dated September 16, 2008 from the Honorable City Mayor Eric C. Codilla relative to the Memorandum of Agreement (MOA) by and between the City Government of Ormoc and Hon. Eufrocino M. Codilla, Sr., Representative, 4th District of Leyte, for the allocation of the amount of P7,500,000.00 out of his congressional funds as financial assistance to the City of Ormoc;

WHEREAS, said Memorandum of Agreement provides that the aforementioned financial assistance shall be utilized for the promotion of health in the City of Ormoc specifically for the purchase of medicines pursuant to the general welfare clause under the Local Government Code;

WHEREAS, health promotion within the Fourth District of Leyte is one of the priority agenda of Congressman Eufrocino M. Codilla, Sr., and providing budgetary support for such program is one of his primary concerns;

WHEREAS, this sanggunian believes that the provisions of the Memorandum of Agreement (MOA) are in order and beneficial to the people, hence, the requested authority of the Honorable City Mayor to sign the same necessitates due course of action;

WHEREFORE, FOREGOING PREMISES CONSIDERED, on motion of City Councilor Ruben R. Capahi, Chairman, Committee on Finance & Appropriation, duly seconded by City Councilor Mariano Y. Corro; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO SIGN THE MEMORANDUM OF AGREEMENT (MOA) IN BEHALF OF THE CITY OF ORMOC WITH THE HONORABLE EUFROCINO M. CODILLA, SR., REPRESENTATIVE, 4TH DISTRICT OF LEYTE FOR THE ALLOCATION OF SEVEN MILLION FIVE HUNDRED THOUSAND PESOS (P7,500,000.00) OUT OF HIS CONGRESSIONAL FUNDS AS FINANCIAL ASSISTANCE TO THE CITY OF ORMOC FOR THE PROMOTION OF HEALTH;
