JESUS HORCA, FOR OPINION REGARDING THE PROPOSED MERGER OF BARANGAY DISTRICT 6, ORNOC CITY WITH ANY OF ITS ADJOINING BARANGAYS NAMELY BARANGAY DISTRICT 5 AND BARANGAY DISTRICT 7.

currently Barangay District 6, Ormoc City, has no set of barangay officials to handle the affairs of said barangay considering that nobody has manifested interest to run or file a Certificate of Candidacy in the last Barangay elections;

WHEREAS, the City Government of Ormoc believes that the prevailing situation In Barangay District 6 should be acted upon promptly so that the delivery of basic public services to its constituents, as mandated by law, will not be hampered;

WHEREAS, as an initial step to address the problem, this sanggunian has requested the respective Heads of Offices of the Barangay Affairs Office, City Planning and Development Office, Liga ng mga Barangay Office and Sangguniang Kabataan (SK) Federation Office to conduct a study and submit a recommendation as to the possibility of merging Barangay District 6 with any of its adjoining barangays namely Barangay District 5 and Barangay District 7 (Copy of the recommendation attached hereto for reference);

WHEREAS, this august Body is aware that the merging of local government units is subject to the limitations and requirements prescribed in the Local Government Code of 1991 particularly on Chapter 2, Sec. 6 - 13 thereof;

WHEREAS, on the supposition that the DILG Office is in the best position to expound further the aforementioned limitations requirements on "MERGER" as prescribed by law, most specifically on population requirements, this sanggunian deems it appropriate to seek and request its opinion on the propriety of the proposed merger;
