RESOLUTION NO. 2008-188

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO SIGN THE MEMORANDUM OF AGREEMENT (MOA) FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC WITH THE PROCUREMENT SERVICE (PS), A GOVERNMENT AGENCY ATTACHED TO THE DEPARTMENT OF BUDGET AND MANAGEMENT, AND THE DEPARTMENT OF BUDGET AND MANAGEMENT - REGIONAL OFFICE VIII (DBM RO VIII).

WHEREAS, this august Body is in receipt of an indorsement dated September 9, 2008 from the Honorable City Mayor Eric C. Codilla requesting for authority to sign the Memorandum of Agreement (MOA) by and between the City Government of Ormoc, the Procurement Service (PS) which is a government agency attached to the Department of Budget and Management and the Department of Budget and Management - Regional Office VIII (DBM RO VIII);

WHEREAS, said Memorandum of Agreement refers to the establishment and operation of a PS Regional Sub-Depot in Ormoc City to be known as PS Sub-Depot - Ormoc, for storing common-use supplies, materials and equipment, for the supply requirements of the city, its LGU components, national government agencies within the city, and national and local agencies in the neighboring cities;

WHEREAS, the concept is pursuant to Executive Order No. 359, Series of 1989 which authorize the Procurement Service (PS) to establish Regional Depots and Republic Act No. 9184 otherwise known as the "Government Procurement Reform Act" which is being implemented in the city in support to the mandate of the Procurement Service;

WHEREAS, this sanggunian believes that the provisions of the Memorandum of Agreement (MOA) are in order and advantageous to the city, hence, the requested authority of the Honorable City Mayor to sign the same should be accorded due course of action;



WHEREFORE, FOREGOING PREMISES CONSIDERED, on motion of City Councilor Sotero M. Pepito, Chairman, Committee on Economic Enterprise, severally seconded by City Councilors Ruben R. Capahi, Jose C. Alfaro, Jr. and Demosthenes F. Tugonon; be it
