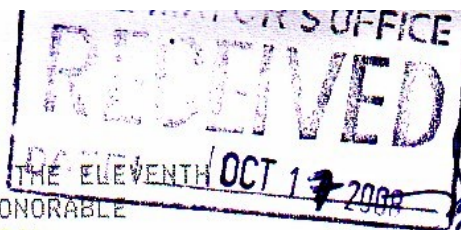

A RESOLUTION APPROVING ORDINANCE NO. 01-2008 OF THE
BARANGAY COUNCIL OF BARANGAY LAO, THIS CITY, ENTITLED:
"AN ORDINANCE AMENDING SOME PROVISIONS OF BARANGAY
ORDINANCE NO. 001 SERIES OF 2008 - "AN ORDINANCE
PRESCRIBING THE RATES ON THE ISSUANCE OF BARANGAY
CLEARANCES AND OTHER CERTIFICATES, PERMITS AND OTHER
CHARGES".

WHEREAS, this Sanggunian is in receipt of Barangay Ordinance NO.
01-2008 of the Barangay Council of Barangay Lao, entitled: "AN ORDINANCE
AMENDING SOME PROVISIONS OF BARANGAY ORDINANCE NO. 001 SERIES OF 2008 -
"AN ORDINANCE PRESCRIBING THE RATES ON THE ISSUANCE OF BARANGAY
CLEARANCES AND OTHER CERTIFICATES PERMITS AND OTHER CHARGES";

AND OTHER CHARGES";


ADOPTED, October 16, 2008.
