RESOLUTION NO. 2008-195

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO ENTER INTO AND SIGN THE PROMISSORY NOTE WITH THE ASSIGNMENT OF INTERNAL REVENUE ALLOTMENT AND THE LOAN AGREEMENT WITH LAND BANK OF THE PHILIPPINES COVERING THE AMOUNT OF THIRTY THREE MILLION NINE HUNDRED EIGHTY TWO THOUSAND TWO HUNDRED EIGHT PESOS (P33,982,208.00).

WHEREAS, the City Government of Ormoc, Leyte, has a receivable from its 2001 and 2004 Internal Revenue Allotment amounting to PESOS: THIRTY THREE MILLION MINE HUNDRED EIGHTY TWO THOUSAND TWO HUNDRED EIGHT ONLY (P33,982,208.00);

WHEREAS, the City Government of Ormoc, Leyte has premised its decision to finance the implementation of priority developmental projects, the Local Government Unit must be able to secure financing or loan from credit institutions:

this Sanggunian has passed Sangguniang Resolution No. 2008-136 dated July 17, 2008, entitled: AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO NEGOTIATE A LOAN FOR AND BEHALF OF THE CITY GOVERNMENT OF ORMOC WITH LAND BANK OF THE AGAINST INTERNAL REVENUE ALLOTMENT RECEIVABLE SUPPORTED BY PHILIPPINES NOTICE OF PAYMENT SCHEDULE (NPS) TO BE USED TO FINANCE THE IMPLEMENTATION OF PRIORITY PROJECTS IN NEED OF ADDITIONAL FUNDING";

WHEREAS, among the requirements of LAND BANK OF THE PHILIPPINES for the disbursement of the approved LOAN AGAINST NOTICE OF PAYMENT SCHEDULE (NPS) OF 2001 and 2004 INTERNAL REVENUE ALLOTMENT (IRA) are the duly executed Promissory Note with assignment of IRA and Loan Agreement mentioned above;

WHEREFORE, on motion of City Councilor Ruben R. Capahi, Chairman, Committee on Finance and Appropriations, duly seconded by City Councilor Mariano Y. Corro; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO ENTER INTO AND SIGN THE PROMISSORY NOTE WITH THE ASSIGNMENT OF INTERNAL REVENUE ALLOTMENT AND THE LOAN AGREEMENT WITH LAND BANK OF THE PHILIPPINES COVERING THE AMOUNT OF THIRTY THREE MILLION NINE HUNDRED EITHY TWO THOUSAND TWO HUNDRED EIGHT PESOS (P33,982,208.00).
