WHEREAS, this august Body is in receipt of an indorsement dated October 14, 2008 from the Honorable City Mayor Eric C. Codilla, in connection with the Memorandum of Agreement (MOA) by and between the aforementioned parties and further requesting for authority to sign the

WHEREAS, the agreement refers to the establishment of a Road-Rightof-Way which shall be used as an access road towards the site of the Water Reservoir which was constructed by the First Party being a major component of the on-going Ormoc City Waterworks System Improvement and Rehabilitation Project;
