RESOLUTION NO. 2008-198

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO SIGN THE MEMORANDUM OF AGREEMENT (MOA) FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC HEREINAFTER REFERRED TO AS THE FIRST PARTY WITH IÑAKI A. LARRAZABAL (IAL) ENTERPRISES REPRESENTED BY ITS PRESIDENT, MRS. MILAGROS L. RIZARRI AS THE SECOND PARTY.

WHEREAS, this sanggunian is in receipt of a communication dated September 24, 2008 from the Honorable City Mayor Eric C. Codilla, requesting for authority to sign the Memorandum of Agreement (MOA) by and between the aforementioned parties in connection with the construction of an access road leading to the site of the Water Filtration Gallery located at Brgy. Donghol, this city;

WHEREAS, said Filtration Gallery was constructed by the First Party after being considered as a major component of the on-going Ormoc City Waterworks System Improvement and Rehabilitation Project;

WHEREAS, the proposed establishment of an access road towards the Filtration Gallery will affect certain lots owned by IAL Enterprises, said lots are hereto identified as follows:

- a) LOT 2919-B PART - 2,882 sq.m. more or less (covered by Psd-08-002692)
- b) LOT 2922-PART - 1,075 sq.m. more or less (covered by TCT No. 10725)
- c) LOT 2923-PART - 523 sq.m. more or less (covered by TCT No. TH 171)
- d) LOT 2924-PART - 2,650 sq.m. more or less (covered by TCT No. 17185)

- e) LOT 2927-PART - 114 sq.m. more or less (covered by TCT No. 10210)
- f) LOT 2929-PART - 341 sq.m. more or less (covered by TCT No. 10161)
- g) LOT 2930-PART - 303 sq.m. more or less (covered by TCT No. 10173)
- h) LOT 2931-PART - 205 sq.m. more or less (covered by TCT No. 10162)
- i) LOT 2932-PART - 1,613 sq.m. more or less (covered by TCT No. 11142)

WHEREAS, the Memorandum of Agreement provides that the Second Party grants perpetual road-right-of-way to the First Party in order to gain access to the site of the said Filtration Gallery and in return the First Party shall carry out the improvement and maintenance of the said access road;

WHEREAS, this sanggunian believes that all the provisions of the Memorandum of Agreement (MOA) are in order hence, the requested authority of the Honorable City Mayor to sign the same should be given the necessary course of action;

WHEREFORE, FOREGOING PREMISES CONSIDERED, on motion of the City Councilor Mariano Y. Corro, Vice-Chairman, Committee on Laws & Ordinances, jointly seconded by City Councilor Fe S. Lladoc and Lea Doris C. Villar; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO SIGN THE MEMORANDUM OF AGREEMENT (MOA) FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC HEREINAFTER REFERRED TO AS THE FIRST PARTY WITH IÑAKI A. LARRAZABAL (IAL) ENTERPRISES REPRESENTED BY ITS PRESIDENT, MRS. MILAGROS L. RIZARRI AS THE SECOND PARTY;

RESOLVED, FURTHER, that a copy of the final and notarized Memorandum of Agreement (MOA) be furnished to this sanggunian for information and file;


