RESOLUTION NO. 2008-201

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS IN BEHALF OF THE CITY GOVERNMENT OF ORMOC FOR THE IMPLEMENTATION OF THE SPECIAL LOCAL ROAD FUND (SLRF) UNDER R.A. 8794 OR THE MOTOR VEHICLE USERS CHARGE (MVUC) LWA.

WHEREAS, this Sanggunian is in receipt of 1st Indorsement dated October 23, 2008 from the office of the City Mayor Eric C. Codilla, urgently requesting for a resolution authorizing His Honor to enter into and sign the Memorandum of Agreement (MOA) with the Department of Public Works and Highways for and in behalf of the City Government of Ormoc for the implementation of the Special Local Road Fund (SLRF) under R.A. 8794 or the Motor Vehicle Users Charge (MVUC) Law;

WHEREAS, this agreement covers the release, utilization and liquidation of funds for the LGU eligible projects and activities such as road maintenance, road safety devices and traffic Management funded by the Special Local Road Fund to be implemented by LGU's in accordance with the policies, standards and procedures of R.A. 8794 (MVUC Law) and its implementing Rules and Regulations;

WHEREAS, the Agreement further specifies the implementation of SLRF Projects along City Roads in the City of Ormoc particularly the installation of New Traffic Signs/ Application Markings/ other Safety Devices and/ or Lighting Improvements at Hermosilla Drive, Ormoc City, Leyte with

exceptions and other Local Roads within the jurisdiction of the City with an appropriation of TWO MILLION PESOS (P2,000,000.00) under the MVUC Special Local Road Fund;

WHEREAS, this august Body believes that said request is reasonable hence, the same be accorded due course of action;

WHEREFORE, foregoing premises considered, on motion of the City Councilor Claudio P. Larrazabal, Chairman, Committee on Infrastructure, jointly seconded by City Councilor Mariano Y. Corro and Rafael C. Omega, Jr.; be it


