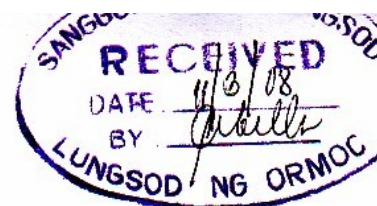

RESOLUTION NO. 2008-203

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO SIGN THE MEMORANDUM OF AGREEMENT AMONG THE DEPARTMENT OF HEALTH- EASTERN VISAYAS (DOH-EV), THE 4TH CONGRESSIONAL DISTRICT OF LEYTE, AND THE CITY GOVERNMENT OF ORMOC.

WHEREAS, this august Body is in receipt of an indorsement dated October 22, 2008 from the Honorable City Mayor Eric C. Codilla in connection with the Memorandum of Agreement (MOA) to be entered into by the aforementioned parties and further requesting for authority to sign the same;

WHEREAS, the Memorandum of Agreement refers to the allocation of the amount of ONE MILLION (P1,000,000.00) PESOS to the City of Ormoc for the purchase of drugs, medicines and other medical supplies subject to the terms and conditions that may be recommended by the Office of Congressman Eufrocino M. Codilla, Sr. with regards to the disposition and utilization thereof;

WHEREAS, the said amount has been sub-allocated to the Department of Health- Eastern Visayas as Subsidy to the Regional Offices under Sub-Allotment Advice No. SAA-08040182 through the initiative of Congressman Codilla;

WHEREAS, in effect thereof, the Department of Health- Eastern Visayas will cause the transfer of said amount to the City of Ormoc;

WHEREAS, this sanggunian finds the provisions of the Memorandum of Agreement (MOA) to be in order hence, the requested authority of the Honorable City Mayor to sign the same necessitates due course of action;

WHEREFORE, FOREGOING PREMISES CONSIDERED, on motion of City Councilor Rafael C. Omega, Jr., Chairman, Committee on Health, severally seconded by City Councilor Filomeno P. Maglasang, Mariano Y. Corro and Sotero M. Pepito; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO SIGN THE MEMORANDUM OF AGREEMENT AMONG THE DEPARTMENT OF HEALTH- EASTERN VISAYAS (DOH-EV), THE 4TH CONGRESSIONAL DISTRICT OF LEYTE, AND THE CITY GOVERNMENT OF ORMOC.


RESOLVED FURTHER, that a copy of the final notarized Memorandum of Agreement (MOA) be furnished to this sanggunian for information and file.
