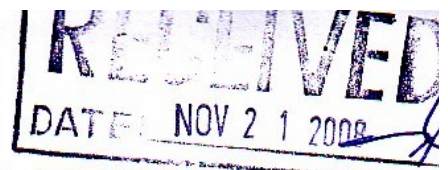

PALMITOS, CIN - 636.




