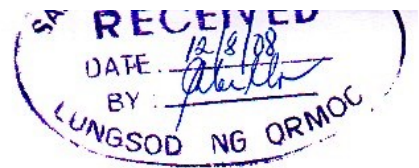

RESOLUTION NO. 2008-225

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C.
CODILLA TO SIGN THE MEMORANDUM OF AGREEMENT (MOA) IN
BEHALF OF THE CITY GOVERNMENT OF ORMOC WITH THE
DEPARTMENT OF HEALTH (DOH) IN CONNECTION WITH THE
RELEASE OF PERFORMANCE-BASED GRANT FACILITY TO THE CITY
OF ORMOC.

WHEREAS, this august Body is in receipt of an indorsement dated
November 11, 2008 from the Honorable City Mayor Eric C. Codilla
requesting for authority to sign the Memorandum of Agreement (MOA) in
behalf of the City Government of Ormoc with the Department of Health
(DOH) in connection with the release of Performance-Based Grant Facility
to the City of Ormoc;

WHEREAS, the said grant facility scheme is made available to LGU's
for the purchase of reproductive health commodities, the conduct of
family planning seminars and programs, and for provision of access to
reproductive health services for the poor which is in consonance with
the commitment of the Department of Health (DOH) to reduce maternal and
child mortality by at least half by CY 2010;

WHEREAS, as cited in the Memorandum of Agreement the LGU of Ormoc
City is considered a SPONSOR of the aforementioned grant facility of the
Department of Health - the determination of which was based on the
results of performance assessment conducted by the DOH under approved
criteria and guidelines;

WHEREAS, the agreement stipulates that as SPONSOR LGU, Ormoc City is entitled to receive up to a maximum of FOUR HUNDRED SIXTY FIVE THOUSAND EIGHTY ONE PESOS and 70/100 (P465,081.70) with an initial release of TWO HUNDRED FOUR THOUSAND SIX HUNDRED THIRTY SIX (P204,636.00) PESOS as grant proceeds, subject to the conditions set forth in the Memorandum of Agreement and its corresponding and appropriate guidelines;

WHEREAS, this august Body finds the Memorandum of Agreement (MOA) to be in order and deemed beneficial to the people;

WHEREFORE, FOREGOING PREMISES, CONSIDERED, on motion of City Councilor Rafael C. Omega, Jr., Chairman, Committee on Health, severally seconded by City Councilors Mariano Y. Corro, Fernando P. Parrilla and Ruben R. Capahi; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO SIGN THE MEMORANDUM OF AGREEMENT (MOA) IN BEHALF OF THE CITY GOVERNMENT OF ORMOC WITH THE DEPARTMENT OF HEALTH (DOH) IN CONNECTION WITH THE RELEASE OF PERFORMANCE-BASED GRANT FACILITY TO THE CITY OF ORMOC;


ADOPTED, December 04, 2008.
