WHEREAS, this Sanggunian is in receipt of an indorsement dated November 21, 2008 from the office of the City Mayor Eric C. Respectfully forwarded to the Office of the City Mayor, this City, the herein I Indorsement by Delia S. Borinaga, Executive Assistant III of said Office dated January 2, 2008, requesting comments and recommendations on the request of Ormoc City Chamber of Commerce and Industry, Inc. for full condonation of interests, penalties and surcharges on the delinquent real property taxes per Resolution No. 8, Series of 2007 dated November 15, 2007, attached, with the following comments, observations and recommendations, to wit:

- 1. Condonation or reduction of real property taxes and interest can be made only in case of general failure of crops or substantial decrease in the price of agricultural or agribased products, or calamity in any province, city or municipality through an ordinance passed upon the recommendation of the Disaster Coordinating Council, per Section 276 of the Local Government Code of 1991
- Tax Amnesty Program was implemented in 2002 for the reason that the City was devastated brought about by several typhoons, calamities and the outbreak of "Malaysian Black Bug" wherein several rice plantations in the City were seriously affected, per Ordinance No. 86 dated February 14, 2002, attached.
- The said Tax Amnesty Program in Calendar 2002 garnered a 3.26% increase of collection only compared to previous year collection of Real Property Taxes per Statement of Real Property Tax Collection for the period from Calendar Years 2001 to 2007, attached. equest of Orașie Chy Campera
- The plan of this Office to apply civil remedies in the collection of delinquent taxes is not to exercise the coercive power to enforce payment of unpaid real property taxes because it is mandated by law and local ordinances. The City Treasurer is required that all remedies for the collection of real property taxes as provided for in the Local Government Code of 1991 be strictly enforced after the expiration of the 2002 Tax Amnesty program which runs from January 1 to December 31, 2002, per Sections 3 and 6 of the above-stated Ordinance.
 - This Office can not find any valid reason to grant the request of Ormoc City Chamber of Commerce, Inc. for the condonation of interests, penalties and surcharges of delinquent real property taxes. So, this Office recommends that said request be denied due to the abovestated comments and observations, demanded in sole
