CODILLA TO ENTER INTO AND SIGN FOR AND IN BEHALF OF THE CITY COVERNMENT OF ORMOC A MEMORANDUM OF AGREEMENT (MOA) WITH THE ORMOC HYBRID RICE SEED PRODUCERS - MULTI-PURPOSE COOPERATIVE (ORHSEPCO-MPC) REPRESENTED BY ITS CHAIRMAN LEGNITO SARSOZA.

WHEREAS, this Sanggunian is in receipt of a letter dated 03 December 2008 from the Honorable City Mayor Eric C. Codilla requesting for authority to sign the Memorandum of Agreement (MOA) with the Ormoc Hybrid Rice Seed Producers - Multi - Purpose Cooperative (ORHSEPCO - MPC) represented by its Chairman Leonito Sarsoaza;
