WHEREAS, this august Body is in receipt of an indorsement dated December 11, 2008 from the Honorable City Mayor Eric C. Codilla in connection with the Memorandum of Agreement (MOA) to be entered into by the City Government of Ormoc with the Ormoc City Federation of Small Hog Raisers, Inc.;
