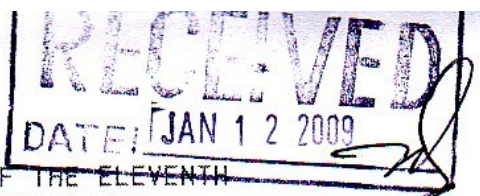

RESOLUTION NO. 2009-004

A RESOLUTION APPROVING ORDINANCE NO. 2008-001 OF THE BARANGAY COUNCIL OF BARANGAY LABRADOR, THIS CITY, ENTITLED: "AN ORDINANCE PROHIBITING OWNERS OF DOMESTIC ANIMALS, SUCH AS PIGS, CATTLE, GOATS, HORSES, AND FOWLS AS TURKEYS, GEESE AND SIMILAR ANIMALS AND FOWLS, FROM CAUSING THEM TO GO ASTRAY, PROVIDING PENALTIES IN VIOLATION THEREOF".

WHEREAS, this Sanggunian is in receipt of Barangay Ordinance No. 2008-001 of the Barangay Council of Barangay Labrador, entitled: "AN ORDINANCE PROHIBITING OWNERS OF DOMESTIC ANIMALS, SUCH AS PIGS, CATTLE, GOATS, HORSES, AND FOWLS AS TURKEYS, GEESE AND SIMILAR ANIMALS AND FOWLS, FROM CAUSING THEM TO GO ASTRAY, PROVIDING PENALTIES IN VIOLATION THEREOF";

WHEREAS, the Sangguniang Panlungsod ng Ormoc, in relation to the aforecited ordinance at issue (and all other ordinances of the Sangguniang Barangay in Ormoc City) is, by law, granted the Power to review as to whether said ordinance is consistent with law and city x x ordinances; (Sec. 57, 1991 LGC)

WHEREAS, it is the observation of this august Body that the said ordinance has conformed to the pertinent provisions of the Local Government Code, hence, reasonable and within the province of the Sangguniang Barangay of Labrador, to legislate;

WHEREFORE, foregoing premises considered, on motion of City Councilor Demosthenes F. Tugonon, Chairman, Committee on Laws and Ordinances, severally seconded by City Councilors Claudio P. Larrazabal, Fe S. Lladoc and Ruben R. Capahi; be it
