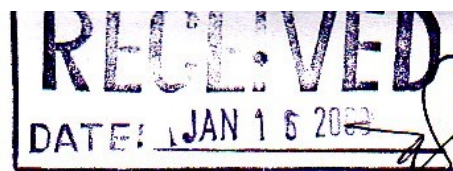

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO SIGN THE CONTRACT OF CONSULTANCY OF DR. SAMUEL S. GO, AS CONSULTANT FOR AGRICULTURE, THIS CITY, EFFECTIVE JANUARY 1, 2009 TO DECEMBER 31, 2009.

WHEREAS, this Sanggunian is in receipt of 1st Indorsement dated December 24, 2008 from the Office of the City Mayor urgently requesting for the passage of a resolution granting the Honorable City Mayor Eric C. Codilla an authority to enter into and sign the contract of consultancy of Dr. Samuel S. Go, as Consultant for Agriculture, this city;


