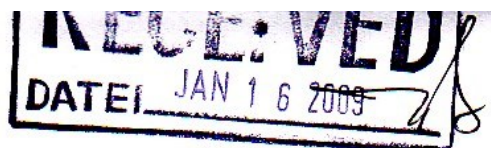

RESOLUTION NO. 2009-010

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH), IN BEHALF OF THE CITY GOVERNMENT OF ORMOC, FOR THE IMPLEMENTATION OF THE SPECIAL LOCAL ROAD FUND (SLRF) FOR CY 2008 AND CY 2009 IN THE AMOUNT OF SIX HUNDRED EIGHTY SEVEN THOUSAND FOUR HUNDRED SIXTY ONE PESOS & 23/100 (P687,461.23) UNDER R.A. 8794 OR THE MOTOR VEHICLE USERS CHARGE (MVUC) LAW.

WHEREAS, this Sanggunian is in receipt of the 1st Indorsement dated December 08, 2008 from the Office of the City Mayor Eric C. Codilla, requesting for a resolution authorizing His Honor to enter into and sign the Memorandum of Agreement (MOA) with the Department of Public Works and Highways (DPWH) for and in behalf of the City Government of Ormoc for the implementation of the Special Local Road Fund (SLRF) under R.A. 8794 or the Motor Vehicle Users Charge (MVUC) Law;

WHEREAS, this agreement covers the release, utilization and liquidation of funds for the LGU eligible projects and activities such as road maintenance, road safety devices and traffic management funded by the Special Local Road fund to be implemented by LGU's in accordance with the policies, standards and procedures of R.A. 8794 (MVUC Law) and its implementing Rules & Regulations;

WHEREAS, the agreement further specifies the implementation of SLRF Projects along City Roads in the City of Ormoc particularly the Preventive Road Maintenance at Barangay Punta, Ormoc City, Leyte with an appropriation of SIX HUNDRED EIGHTY SEVEN THOUSAND FOUR HUNDRED SIXTY ONE PESOS & 23/100 (P687,461.23) under the MVUC Special Local Road Fund;

WHEREAS, this august Body believes that said request is reasonable, hence, the same be accorded due course of action;

WHEREFORE, foregoing premises considered, on motion of the City Councilor Claudio P. Larrazabal, Chairman, Committee on Infrastructure, severally seconded by City Councilors Ruben R. Capahi, Sotero M. Pepito and Mariano Y. Corro; be it


ADOPTED, January 15, 2009.
