RESOLUTION NO. 2009-012

A RESOLUTION INTERPOSING NO OBJECTION TO THE APPLICATION  
OF MR. RODULFO PONGOS TO OPERATE A POULTRY WITHIN THEIR  
PARCEL OF LAND LOCATED IN BARANGAY CAMP DOWNES, ORMOC  
CITY BASED ON THE RESOLUTION APPROVED BY THE  
SANGGUNIANG BARANGAY OF BARANGAY CAMP DOWNES.

WHEREAS, the Sangguniang Panlungsod ng Ormoc is in receipt of a  
resolution coming from the Sangguniang Barangay of Barangay Camp Downes,  
entitled: "A RESOLUTION INTERPOSING NO OBJECTION AND AT THE SAME TIME  
ENDORING THE APPROVAL OF SANGGUNIANG PANLUNGSOD AND THE OFFICE OF THE  
CITY MAYOR THE APPLICATION FOR PERMIT FOR OPERATION OF POULTRY BUSINESS  
OF MR. RODULFO PONGOS IN THEIR PARCEL OF LAND LOCATED UNDER THE  
JURISDICTION OF BRGY. CAMP DOWNES ABOUT A KILOMETER FROM THE BARANGAY  
POBLACION";

WHEREAS, it is not within the authority of the Sangguniang  
Panlungsod to pass an approval of the said application but only to  
interpose no objection of such application as the case may be;

WHEREAS, based on the resolution of the Sangguniang Barangay and  
the result of their public consultation as stated in their resolution of  
approval of said project, the Sangguniang Panlungsod interposes no  
objection to the said project of Mr. Rodulfo Pongos;

WHEREAS, this resolution concerning the resolution of Barangay Camp  
Downes interposing no objection is however subject to the condition that  
Mr. Rodulfo Pongos or his representative should secure the necessary  
Environmental Compliance Certificate (ECC) first prior to the  
development and operation of said poultry since it has a capacity of  
40,000 birds;



WHEREFORE, FOREGOING PREMISES CONSIDERED, on motion of the City Councilor Mariano Y. Corro, Member, Committee on Natural Resources and Environmental Control, duly seconded by City Councilor Ruben R. Capahi; be it


RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution INTERPOSING NO OBJECTION TO THE APPLICATION OF MR. RODULFO PONGOS TO OPERATE A POULTRY WITHIN THEIR PARCEL OF LAND LOCATED IN BARANGAY CAMP DOWNES, ORMOC CITY BASED ON THE RESOLUTION APPROVED BY THE SANGGUNIANG BARANGAY OF BARANGAY CAMP DOWNES;
